Mrs. Wright welcomed the new council and stated she looks forward to working with them to accomplish the city's goals over the next two years.

NEW BUSINESS AND COMMITTEE REPORTS:

1. Clerk of Court Report

Mrs. George gave the Mayor's Court Report for November 2007. Mr. Sylvester motioned to approve the Mayor's Court Report and was seconded by Mrs. Glover. All voted aye. Motion carried.

2. Budget Report

Mr. Peterson gave the November 2007 Budget Report. Mrs. Glover motioned to approve the Budget Report and was seconded by Mr. Quarry. All voted aye. Motion carried.

COMMITTEE REPORTS:

1. Councilwoman Garner

ICRC - No report. The next meeting is scheduled for January 24, 2008.

2. Councilman Sylvester

Planning Commission – Mr. Sylvester reported the Planning Commission recently met to review and approve the RFP for the zoning re-write.

3. Councilwoman Glover

LSDMC - No report.

4. Councilwoman Williams

Fire Board — Mrs. Williams reported that the Fire Board met on 12/11/07. The 2008 Budget was discussed, as well as the P.O.D. project, which helps citizens receive immunizations in the event of a pandemic. Additionally, the Fire District has applied for 2 grants, and just received word that they will be awarded a \$270,000 grant for a new fire truck. Mrs. Idella Thompson, former board member, was honored for her service to the board.

5. Councilman Quarry

HCSWD - No report.

OKI – No report.

Park Board – Mr. Quarry reported that Santa at the Train Station was cancelled due to inclement weather and due to his busy holiday schedule is unable to reschedule for this year. The Park Board will meet in January to discuss and plan events for 2008.

6. Councilwoman Hackett

Urban Forestry Board – Mrs. Hackett reported that she attended a Winter Tree and Shrub seminar at Northern Kentucky University that was very informative. The hazardous tree walk scheduled for December 13 was postponed due to inclement weather; however the UFB had a great in-service with Wendi Van Buren in lieu of the tree walk. The next UFB meeting is scheduled for January 17, 2008 at 4:00 p.m. in the Municipal Building. All are welcome.

OPEN DISCUSSION / NEW ISSUES BY ELECTED OFFICIALS:

Mr. Wendling reminded everyone that the City Offices will be closed on Monday, December 24 and Tuesday, December 25, 2007. The offices will also be closed on Tuesday, January 1, 2008.

Mr. Wendling also reported that Mr. Dave Emerick, the City's longtime engineer, will be leaving CDS at the end of the year to take a job with Duke Energy. Mr. Emerick will be greatly missed. Pat Madl will be doing the majority of Silverton's engineering work, under the supervision of a lead engineer who has not yet been selected.

Mr. Quarry asked if the Ohio Plan Major Medical quote had come back yet. Mr. Wendling stated it had not, although he expects it soon. Mr. Quarry asked if health insurance could be a shared service with the county. Mr. Wendling reported it could, however, when it was looked into it was not beneficial to the City.

Mrs. Hackett reported an incident of panhandling at a Silverton business. Mr. Wendling stated he would report it to the police and advised business owners to call the police immediately if the situation occurs at their place of business.

READING OF LEGISLATION:

Mrs. George gave the reading of Ordinance 07-3259 An Ordinance to Levy Special Assessments on Property for the Total Cost of Mitigating Noxious Weeds and High Grass Pursuant to Sections 91.70 - .73 of the Municipal Code of Ordinances and R.C 715.261 and Declaring an Emergency. Mrs. Hackett motioned for adoption and was seconded by Mr. Sylvester. A roll call vote was taken. All voted aye. Motion carried. Mrs. Glover motioned to suspend the rules and was seconded by Mr. Quarry. A roll call vote was taken. All voted aye. Motion carried.

Mrs. George gave the reading of Resolution 07-531 A Resolution to the County Auditor to Make Advance Payments of Taxes during the Year 2008 Pursuant to ORC Section 321.34. Mrs. Garner motioned for adoption and was seconded by Mrs. Hackett. A roll call vote was taken. All voted aye. Motion carried.

Mrs. George gave the reading of Resolution 07-533 A Resolution Authorizing the City Manager to Submit Application to and Enter into Contract with the Ohio Public Works Commission for State Capital Improvement Program (SCIP) Funds. Mr. Sylvester motioned for adoption and was seconded by Mr. Quarry. A roll call vote was taken. All voted aye. Motion carried.

Mrs. George gave the reading of Resolution 07-534 A Resolution for the Compensation of the Position of City Solicitor of the City of Silverton, Ohio. Mr. Quarry motioned for adoption and was seconded by Mr. Sylvester. A roll call vote was taken. All voted aye. Motion carried.

Mrs. George gave the reading of Resolution 07-535 A Resolution awarding the contract for the Plainfield Montgomery Intersection Improvement Project to Prus Construction. Mrs. Glover motioned for adoption and was seconded by Mrs. Garner. A roll call vote was taken. All voted aye. Motion carried.

MOTION TO ADJOURN MEETING:

Motion to adjourn was made by Mrs. Glover and seconded by Mr. Quarry. All present voted in favor. Motion carried.
