ORDINANCE NO. 23-3715

ORDINANCE AUTHORIZING THE VILLAGE MANAGER TO OFFER FOR AUCTION THROUGH THE HAMILTON COUNTY ON-LINE PUBLIC AUCTION TWO BRIGGS & STRATTON GENERATORS, AND DECLARING AN EMERGENCY

WHEREAS, Article X, Section 13 of the Charter provides that "personal property may be sold as provided by ordinance;" and

WHEREAS, the Village determined that it should sell at auction, via the Hamilton County On-Line Public Auction, two Village-owned generators, more fully described in the attached Exhibit A because they are no longer needed for public purposes, and

WHEREAS, the Village Manager is hereby authorized to take the necessary steps to auction the Vehicle using the Hamilton County On-Line Public Auction and to deposit any sale proceeds into the Village's General Fund.

NOW THEREFORE, BE IT ORDAINED by the Village Council of Silverton, that:

SECTION I.

Village Council has determined that it is in the best interests of the Village to auction the generators because they are no longer needed for public purposes and to deposit any of the sale proceeds into the Village's General Fund.

SECTION II.

The Village Manager is hereby authorized to take whatever steps are necessary to sell the generators via the Hamilton County On-Line Public Auction.

SECTION III.

This Ordinance is declared to be an emergency measure necessary to preserve the public peace, health, safety and welfare of the citizens of the Village of Silverton; the reason for the emergency being the need to liquidate surplus equipment and to collect the resulting revenue from such sale as quickly as possible. Accordingly, this Ordinance shall take effect and be in force immediately from and after its passage and approval.
