ORDINANCE NO. 18-3586

AN ORDINANCE SETTING FORTH AND ESTABLISHING SOLID WASTE RATES FOR SILVERTON CUSTOMERS PURSUANT TO A FIVE-YEAR CONTRACT WITH RUMPKE OF OHIO, INC., WHICH RATES SHALL BE IN EFFECT ON JULY 1, 2018 THROUGH JUNE 30, 2023, AND DECLARING AN EMERGENCY

WHEREAS: Under Article X, Section 8 of the Charter, the Village solicited competitive bids for solid waste services in 2017, and the Village Council agreed to enter into a five-year contract with Rumpke of Ohio, Inc. on September 21, 2017; and

WHEREAS: The Village Council determined that Rumpke of Ohio, Inc. who, in Council's judgment, offered the best proposition for the municipality considering quality, service, adaptability to the requirements of the Village and price; and

WHEREAS: Sections 50.30 and 50.31 of the Municipal Code of Ordinances provide that the rate to be charged residential and business users for solid waste collection services shall be set by law and Section 50.34 of the Municipal Code of Ordinances provides that waste collection fees are "inseparably linked to water service fees"; and

WHEREAS: The Village of Silverton desires to set forth the rates for solid waste collections to charge residents and businesses to cover the costs of contracting for such services, including but not limited to, collecting solid waste, semi-weekly recycling services, picking up brush for residents, and charging and collecting the same fees through the Greater Cincinnati Water Works; and

WHEREAS: The Village of Silverton is adding semi-weekly curbside recycling for all residents starting July 1, 2018, and the Village Council will be phasing in the cost increases to customers with a subsidy from the Village's General Fund, and thus the rate charged to customers increase between July of 2018 and July of 2020, even though Rumpke's rates are flat for the five-year contract.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF SILVERTON, OHIO, THAT:

SECTION I.	The Village Manager is hereby authorized to take means necessary to collect
	fees for service for the collection of charges for solid waste set forth herein.

The rate to be charged to each of the residential users and business users of the waste removal services covered by the Silverton Contract with Rumpke of Ohio, Inc. shall be set according to the scheduled attached hereto and made part hereof as Exhibit A.

SECTION III. The rates charged for the years July 1, 2019 through June 30, 2023 in Exhibit A shall continue indefinitely beyond June 30, 2023 unless otherwise repealed or amended by Village Council.

SECTION IV. Any prior measure setting forth rates which are in conflict with the rates for solid waste services in Exhibit A shall be null and void and the rates in Exhibit A shall govern.

SECTION IV. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of

the citizens of the Village of Silverton and shall take effect and be in force from and immediately after its passage and approval; the reason for the emergency being the immediate need for the Village to communicate the new rates starting July 1, 2018 to the Greater Cincinnati Water Works and thus enable the Greater Cincinnati Water Works to adjust the bills they send on Silverton's behalf for services in July.
