

ORDINANCE NO. 21-3672

AN ORDINANCE ESTABLISHING MAYORAL AND COUNCIL MEMBER SALARIES, EFFECTIVE DECEMBER 2023, AFTER THE CURRENT MAYOR AND COUNCIL MEMBERS' TERMS OF OFFICE HAVE EXPIRED

WHEREAS, Article III, Section Four of the Village of Silverton Charter provides that “the Mayor’s salary shall be established by ordinance;” and

WHEREAS, Article IV, Section Six of the Village of Silverton Charter provides the “[s]alaries of Council members shall be established by Ordinance...;” and

WHEREAS, the current salaries for the Mayor and Council Members were last amended in 2014, effective in December of 2017. Prior to this 2014 amendment, Council salaries had not been altered since 1983; and

WHEREAS, no current elected official of the Village of Silverton will receive any additional compensation during their term of office nor by ordinance passed subsequent to the final date which they could be nominated for office.

WHEREAS, the salaries established by this ordinance will not become effective until December 1, 2023 so that the current Mayor and current Council Members’ salaries will not be changed during their respective terms in office; and

WHEREAS, the Mayor and Council Members dedicate considerable amounts of time and energy to ensure the proper and continued functioning of the Village and its governing thereby demonstrating their commitment to the Village and their responsibilities as elected officials.

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Silverton, Ohio, that:

**SECTION I.** The salary and compensation for the Mayor shall be \$650.00 per month, for a total of \$7800.00 per year, effective December 1, 2023.


**SECTION II.** The salary and compensation of each Council Member shall be \$400.00 per month, for a total of \$4800.00 per year, effective December 1, 2023.

**SECTION III.** This Ordinance shall take effect at the earliest time provided by law, provided that the salaries established hereunder shall not become effective until December 1, 2023.


