ORDINANCE NO. 22-3698

AN ORDINANCE AUTHORIZING THE VILLAGE MANAGER TO TRADE-IN A 2014 DODGE CHARGER AND A 2011 FORD CROWN VICTORIA, AND DECLARING AN EMERGENCY

WHEREAS, Article X, Section 13 of the Charter provides that "personal property may be sold as provided by ordinance;" and

WHEREAS, the Village has determined that it should trade-in a Village-owned 2014 Dodge Charger and a 2011 Ford Crown Victoria, more fully described in the attached Exhibit A (the "Vehicles"), because they are no longer needed for public purposes, and

WHEREAS, the Village Manager is hereby authorized to take the necessary steps to liquidate the Vehicles using any means necessary and to deposit any sale proceeds into the Village's General Fund.

NOW THEREFORE, BE IT ORDAINED by the Village Council of Silverton, that:

SECTION I.

Village Council has determined that it is in the best interests of the Village to liquidate the Vehicles because they are no longer needed for municipal or public purposes and to deposit any of proceeds from their liquidation into the Village's General Fund.

SECTION II.

The Village Manager is hereby authorized to take whatever steps are necessary to liquidate the Vehicles.

SECTION III.

This Ordinance is declared to be an emergency measure necessary to preserve the public peace, health, safety and welfare of the citizens of the Village of Silverton; the reason for the emergency being the need to liquidate the Vehicles which are no longer needed for municipal or public purposes and to collect the resulting revenue from such liquidation at the earliest possible time. Accordingly, this Ordinance shall take effect and be in force immediately from and after its passage and approval.
