## **RESOLUTION 16-728**

## A RESOLUTION AUTHORIZING THE VILLAGE MANAGER TO CONTINUE HEALTH INSURANCE COVERAGE THROUGH THE CENTER FOR LOCAL GOVERNMENT BENEFITS POOL

WHEREAS: The Village of Silverton, Ohio wishes to continue to acquire employee medical benefits, including vision and dental care, as a member of the Center for Local Government Benefits Pool offered through The Center for Local Government; and

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Silverton, Ohio that:

SECTION I. The Village of Silverton is a member of the Center for Local Government Benefits Pool (hereinafter "Benefits Pool") and shall abide by all provisions of the Participation Agreement, The Pool Agreement, The Jefferson Health Plan Agreement, and other rules and regulations of the Benefits Pool as established by its governing body.

SECTION II. The Village of Silverton shall purchase the Gold A Benefit Plan with the same level of HRA and HSA participation being paid by the Village as it has in previous years. Moreover, employees have been provided the option to continue with the Platinum A Benefit Plan, with additional premium costs for 2016-2017 above current rates being born by the employees, and with HRA and HSA contributions remaining unchanged.

<u>SECTION III.</u> The Village Manager is hereby authorized to execute on behalf of the Village of Silverton any and all agreements, contracts, resolutions, instruments, certificates, forms and other documents, and take any and all actions required for the Village of Silverton to continue to acquire insurance as a Member of the Benefits Pool, or otherwise effectuate this resolution.

SECTION IV. It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were taken in an open meeting of this Council, and that all deliberations of this Council and any committees that resulted in those formal sessions were in meetings open to the public, in compliance with all legal requirements.

SECTION V. This Resolution shall take effect and be in force from and after its passage and approval.
