## RESOLUTION NO. 16-734

## A RESOLUTION AWARDING THE CONTRACT FOR THE NORTH AVENUE RECONSTRUCTION AND WATERLINE REPLACEMENT PROJECT, AND ADDITIONAL BID ALTERNATES, TO THE FRED NEMANN COMPANY

WHEREAS: under Ohio Revised Code Section 735.05, and Article X Section 8 of the Charter of the Village of Silverton, the Village of Silverton solicited and received bids for the South Avenue Improvement Project; and

WHEREAS: the Fred Nemann ("Nemann") is a qualified company to furnish labor, materials, and equipment necessary to complete the North Avenue Improvement Project and alternate 1 and Council has determined that Nemann offers the best proposition for the Village to accomplish said Project, considering quality, service, adaptability to the Village's requirements, and price; and

WHEREAS: under Village Charter Article X, Section 10, the Village Manager is authorized to contract for construction maintenance or repair of any public work or improvement; and

WHEREAS: Nemann provided competitive pricing for additional road and waterline improvements in the competitive bidding process, and has provided competitive cost estimates for alternate 2-7 as well; and

WHEREAS: the Village of Silverton desires to enter into a contract with Nemann to furnish labor, materials, and equipment necessary to complete the various road and waterline improvements bid in 2016-2017.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF SILVERTON, OHIO, THAT:

**SECTION I.** 

Council hereby determines that Nemann offers the best proposition for the Village to accomplish the Project, considering quality, service, adaptability to the Village's requirements, and price. Accordingly, the Village Manager is hereby authorized to enter into a contract and subsequent change orders with Nemann to complete the North Avenue Improvements, and alternates 1-7, a copy of which is on file in the administrative office of the Village of Silverton.

SECTION II.

This Resolution shall be in force and effect from the earliest time provided by law.
