

RESOLUTION NO. 17-756

**A RESOLUTION AWARDING THE CONTRACT
FOR THE 2017 SIDEWALK IMPROVEMENTS ON ELM, SOUTH, WEST FORDHAM, AND
NORTH FORDHAM, TO THE FRED A. NEMANN COMPANY**

WHEREAS: under Ohio Revised Code Section 735.05, and Article X Section 8 of the Charter of the Village of Silverton, the Village of Silverton solicited and received bids for the South Avenue Improvement Project; and

WHEREAS: the Fred A. Nemann Company ("Nemann") is a qualified company to furnish labor, materials, and equipment necessary to complete the 2017 Sidewalk Improvements Project and Council has determined that Nemann offers the best proposition for the Village to accomplish said Project, considering quality, service, adaptability to the Village's requirements, and price; and

WHEREAS: under Village Charter Article X, Section 10, the Village Manager is authorized to contract for construction maintenance or repair of any public work or improvement; and


WHEREAS: the Village of Silverton desires to enter into a contract with Nemann to furnish labor, materials, and equipment necessary to complete the various sidewalk improvements bid opened and publically read on May 15, 2017.

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF SILVERTON, OHIO, THAT:

SECTION I. Council hereby determines that Nemann offers the best proposition for the Village to accomplish the Project, considering quality, service, adaptability to the Village's requirements, and price. Accordingly, the Village Manager is hereby authorized to enter into a contract and subsequent change orders with Nemann to complete the 2017 Sidewalk Improvements, a copy of which is on file in the administrative office of the Village of Silverton.


SECTION II. This Resolution shall be in force and effect from the earliest time provided by law.


