

RESOLUTION NO. 17-769

**A RESOLUTION REJECTING ALL BIDS  
FOR THE PARK AVENUE ROAD PROJECT  
AND DIRECTING THE VILLAGE MANAGER TO REBID**

**WHEREAS:** under Ohio Revised Code Section 735.05, and Article X Section 8 of the Charter of the Village of Silverton, the Village of Silverton solicited and received bids for the Park Avenue Improvement Project; and

**WHEREAS:** six qualified firms submitted bids for the project which included road reconstruction, waterline replacement, and water lateral replacements as needed on Park Avenue; and

**WHEREAS:** the apparent low bidder submitted a low price for the Village of Silverton's road replacement work but had the highest total price for replacing the water main to be paid for by the Greater Cincinnati Water Works, as well as a higher price for the replacement of water laterals by at least 12 homes along Park Avenue; and

**WHEREAS:** if the Village of Silverton to award the road work to the apparent low bidder the Village of Silverton and Greater Cincinnati Water Works would pay more in total public dollars, and the property owners along Park Avenue would have to pay more for lateral replacements; and

**WHEREAS:** Village Council reserved the right to accept or reject any bids in the bid specifications; and


**WHEREAS:** the Village of Silverton Village Council desires to rebid this project with more clear award criteria and complete this rebidding process by December 6, 2017.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF SILVERTON, OHIO, THAT:**


**SECTION I.** Village Council hereby rejects all bids opened on November 3, 2017 for the Park Avenue Improvement Project. Further, Village Council directs the Village Manager to rebid the project with a public bid opening date of no later than December 6, 2017 so as to be able to award a contract for this project on December 14, 2017.

**SECTION II.** This Resolution shall be in force and effect from the earliest time provided by law.


