

RESOLUTION NO. 18-790

A RESOLUTION REQUESTING THE COUNTY AUDITOR
TO MAKE ADVANCE PAYMENTS OF TAXES DURING THE YEAR 2019
PURSUANT TO OHIO REVISED CODE SECTION 321.34

WHEREAS: The Ohio Revised Code allows a taxing authority to request payment from the County Auditor funds derived from taxes or other sources to the County Treasurer, which may be held on account of a local subdivision; and

WHEREAS: The Village of Silverton wants to request such payment from the County Auditor and County Treasurer.


NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF SILVERTON THAT:

SECTION I. The Auditor and the Treasurer of Hamilton County, in accordance with Ohio Revised Code § 321.34, are hereby requested to draw and to pay to the Village of Silverton upon the written request of the Village Manager, and the Village Finance Director, to the County Auditor, funds due in any settlement of 2017 derived from taxes or other sources, payable to the County Treasurer to the account of the Village of Silverton, and lawfully applicable for purposes of the current fiscal year.

SECTION II. That the Clerk of Council of the Village of Silverton shall forward to the County Auditor a certified copy of this resolution.


SECTION III. This Resolution shall take effect and be in full force from and after the earliest period allowed by law.




