

RESOLUTION NO. 19-805

**A RESOLUTION COUNTING THE ADDITIONAL APPROPRIATION MADE
PURSUANT TO ORDINANCE 2019 – 3622 AS THE 2020 “ART IN PUBLIC PLACES”
SET ASIDE FOR FISCAL YEAR 2020 PURSUANT TO RESOLUTION 16-744**

WHEREAS, Village Council adopted Resolution 16-744 in December 2016 which annually sets aside 1% of the Village’s capital budget for art in public spaces; and

WHEREAS, Silverton followed this resolution in fiscal years 2017 and 2018 and implemented its first public art installation in 2018 (All in this Story Together mural); and

WHEREAS, Village Council adopted Resolution 18-794 in December 2018, which resolution waived Council’s obligations pursuant to Resolution 16-744 for the 2019 fiscal year only because of extraordinary one-time expenditures associated with litigation with LLK LLC for right-of-way acquired for the Montgomery and Stewart roads project; and

WHEREAS, despite the fiscal challenges presented by the LLK litigation, the Village of Silverton proceeded with its second Art in Public Spaces installation at Silverton Park; and

WHEREAS, the art piece selected for Silverton Park required an additional appropriation from Village Council to ensure its full and proper implementation, which required a supplemental appropriation pursuant to Ordinance 2019 – 3622 of \$20,000; and

WHEREAS, the Village Council’s supplemental appropriation for the Silverton Park project in fiscal year 2019 is in spite of the waiver Council provided via Resolution 18-794; and


WHEREAS, the Village Council wishes to count the supplemental appropriation for the Silverton Park project adopted on September 5, 2019 as fulfilling its self-imposed obligation to set aside 1% of its capital budget annual for public art for the upcoming fiscal year, 2020.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Silverton,
That:


SECTION I. The Village Council of the Village of Silverton hereby considers its obligation pursuant to Resolution 16-744 satisfied for the 2020 fiscal year because of its supplemental appropriation for public art pursuant to Ordinance 2019 – 3622. Village Council shall resume its self-imposed obligation for its annual 1% for the arts capital set aside pursuant to Resolution 16-744 for fiscal year 2021, or it shall waive this obligation with another resolution.

SECTION II. This Resolution shall be in force and effect from the earliest time provided by law.


