

RESOLUTION NO. 19-811

**A RESOLUTION AWARDING THE CONTRACT  
FOR THE SILVERTON PARK IMPROVEMENTS  
TO SCHWEITZER CONSTRUCTION**

WHEREAS: under Ohio Revised Code Section 735.05, and Article X Section 8 of the Charter of the Village of Silverton, the Village of Silverton solicited and received bids for the Silverton Park Project ("Project"); and

WHEREAS: Schweitzer Construction ("Schweitzer") is a qualified company to furnish labor, materials, and equipment necessary to complete the Project and Council has determined that Schweitzer offers the best proposition for the Village to accomplish said Project, considering quality, service, adaptability to the Village's requirements, and price; and

WHEREAS: under Village Charter Article X, Section 10, the Village Manager is authorized to contract for construction maintenance or repair of any public work or improvement; and

WHEREAS: Schweitzer provided competitive pricing for the scope of work detailed in the bid specifications; and


WHEREAS: the Village of Silverton desires to enter into a contract with Schweitzer to furnish labor, materials, and equipment necessary to complete the various road improvements bid as soon as practical.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF SILVERTON, OHIO, THAT:**

**SECTION I.** Council hereby determines that Schweitzer offers the best proposition for the Village to accomplish the Project, considering quality, service, adaptability to the Village's requirements, and price. Accordingly, the Village Manager is hereby authorized to enter into a contract and subsequent change orders with Schweitzer to complete the Silverton Park Project, a copy of which is on file in the administrative office of the Village of Silverton.

**SECTION II.** This Resolution shall be in force and effect from the earliest time provided by law.
