RESOLUTION NO. 20-818

RESOULTION COMMEMORATING THE 100TH ANNIVERSARY OF THE 19TH AMENDMENT

WHEREAS, 100 years ago on August 19, 1920, the 19th amendment was officially ratified by Congress and a two-thirds majority of states, and

WHEREAS, the amendment explicitly gave female U.S. citizens of legal age the right to vote for elected officials, a right denied to them on a national level in the United States for more than a century, and

WHEREAS, various, newly formed states and territories gradually paved the way for the creation and later ratification of the 19th amendment because they granted the franchise on a state level, and

WHEREAS, a movement known as the Suffragettes, feminists such as Susan B. Anthony and Elizabeth Cady Stanton as well as various other activists, advocated over many years to earn women the right to vote, and

WHEREAS, by giving the franchise to woman, one of the pillars of discrimination against women was removed, furthering the principle that all are created equal; and

WHEREAS, it is important to recognize the tremendous social progress that was achieved a mere century ago and to acknowledge an important event in American history that has since expanded to the voices of many women in the realm of politics, and

WHERAS, this event serves as a reminder that progress can prevail through hard work. passion, persistence and spirit.

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Silverton. Ohio that

SECTION I.	The Village Council of Silverton hereby marks the 100 th anniversary of the ratification of the 19 th amendment.
SECTION II.	The Village Council of Silverton encourages all residents of this community to ponder the ways in which our lives today have been made better by the ratification of the 19 th amendment, as well as to appreciate the long battle that was fought to pass this amendment.
SECTION III.	The Village Council of Silverton continues to hold on to, maintain, and expand the principle of equality as demonstrated in the passing of the 19 th amendment.

This Resolution shall take effect and be in force from and after its SECTION IV. passage and approval.
