

**RESOLUTION NO. 23-876**

**RESOLUTION AWARDING THE CONTRACT  
FOR THE SILVERTON TOWN COMMONS PROJECT TO PRUS CONSTRUCTION, INC.**

**WHEREAS:** under Ohio Revised Code Section 735.05, and Article X Section 8 of the Charter of the Village of Silverton, the Village of Silverton solicited and received bids for the Silverton Town Commons Project (“Project”); and

**WHEREAS: Prus Construction, Inc.** (“Prus”) is a qualified company to furnish labor, materials, and equipment necessary to complete the Project and Council has determined that Prus offers the best proposition for the Village to accomplish said Project, considering quality, service, adaptability to the Village’s requirements, and price; and

**WHEREAS:** under Village Charter Article X, Section 10, the Village Manager is authorized to contract for construction maintenance or repair of any public work or improvement; and

**WHEREAS:** Prus provided competitive pricing for the scope of work detailed in the bid specifications; and

**WHEREAS:** the Village of Silverton desires to enter into a contract with Prus to furnish labor, materials, and equipment necessary to complete the various road improvements bid as soon as practical.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF SILVERTON, OHIO, THAT:**

**SECTION I.** Council hereby determines that Prus offers the best proposition for the Village to accomplish the Project, considering quality, service, adaptability to the Village’s requirements, and price. Accordingly, the Village Manager is hereby authorized to enter into a contract and subsequent change orders with Prus to complete the Silverton Town Commons Project, a copy of which is on file in the administrative office of the Village of Silverton.

**SECTION II.** This Resolution shall be in force and effect from the earliest time provided by law.


