DISTRICT 4 HAMILTON COUNTY SHERIFF'S OFFICE REPORT:

Lt. Reid had a conflict, so Mr. Cameron gave the HCSO report.

- 175 traffic warnings and/or citations were issued in September 2025.
- Speeding on Montgomery Road has decreased.
- The HCSO has free gun locks for residents.
- Lt. Reid and Deputy Campbell spent time at Silverton Elementary with the therapy dog and showing the students how drones work.
- The DEA Drug Take-Back event is Saturday, October 25 from 10 a.m. 2 p.m. at Town Hall.
- The HCSO will begin collecting toys for their annual Toys for Tots campaign on October 20
- Over 300 coats were collected for the annual coat drive. The coats were distributed from the Olivet Church Food Pantry. Extra coats were donated to other local social service organizations.
